Early voting by personal appearance will be conducted by the Galveston County Clerk between the hours of 8:00 a.m. through 5:00 p.m. from October 23, 2017 through October 27, 2017; and between the hours of 7:00 a.m. to 7:00 p.m. on October 30-31, 2017 and November 1-3, 2017. Early voting by personal appearance will be held at the main early voting polling location, Galveston County Justice Center, 600 59th Street, 2nd floor conference room, Galveston, Texas and at various other early voting polling locations as determined by the County. A detailed listing of all early voting polling locations may be obtained from the Galveston County Clerk. Early ballots for voting by mail may be obtained from and mailed to Dwight D. Sullivan, P.O. Box 17253, Galveston, Texas 77552-7253, the official mailing address for the early voting clerk. Applications for ballots by mail must be received no later than the close of business on October 27, 2017.

The following proposition shall be submitted at the November 7, 2017 election:

PROPOSITION

SHALL THE BOARD OF DIRECTORS OF GALVESTON COUNTY MUNICIPAL UTILITY DISTRICT NO. 12 OF GALVESTON COUNTY, TEXAS, BE AUTHORIZED TO ISSUE THE BONDS OF SAID DISTRICT IN ONE OR MORE ISSUES OR SERIES IN THE MAXIMUM AMOUNT OF \$4,400,000, MATURING SERIALLY OR OTHERWISE IN SUCH INSTALLMENTS AS ARE FIXED BY SAID BOARD OVER A PERIOD OR PERIODS NOT EXCEEDING FORTY (40) YEARS FROM THEIR DATE OR DATES, BEARING INTEREST AT ANY RATE OR RATES AND TO SELL SAID BONDS AT ANY PRICE OR PRICES, PROVIDED THAT THE NET EFFECTIVE INTEREST RATE ON ANY ISSUE OR SERIES OF SAID BONDS SHALL NOT EXCEED THE MAXIMUM LEGAL LIMIT IN EFFECT AT THE TIME OF ISSUANCE OF EACH SUCH ISSUE OR SERIES ALL AS MAY BE DETERMINED BY THE BOARD OF DIRECTORS OF SAID DISTRICT, FOR THE PURPOSE OR PURPOSES OF REPAIRING, IMPROVING OR EXTENDING A WATERWORKS SYSTEM, SANITARY SEWER SYSTEM, DRAINAGE AND STORM SEWER SYSTEM, AND NAVIGABILITY OF COASTAL AND INLAND WATERS OF THE DISTRICT, AND/OR PURCHASING, CONSTRUCTING, ACQUIRING, OWNING, AND OPERATING SUCH SYSTEM, INCLUDING BUT NOT LIMITED TO, ALL ADDITIONS TO SUCH SYSTEM AND ALL WORKS, IMPROVEMENTS, FACILITIES, EQUIPMENT, APPLIANCES, INTEREST IN PROPERTY, AND CONTRACT RIGHTS NEEDED THEREFOR AND ADMINISTRATIVE FACILITIES NEEDED IN CONNECTION THEREWITH, AND FOR THE FURTHER PURPOSE OF REFUNDING ALL OR ANY PART OF THE PRINCIPAL OF OR INTEREST ON THE DISTRICT'S BONDS NOW OR HEREAFTER OUTSTANDING, AND TO PROVIDE FOR THE PAYMENT OF PRINCIPAL OF AND INTEREST ON SUCH BONDS BY THE LEVY AND COLLECTION OF A SUFFICIENT TAX UPON ALL TAXABLE PROPERTY WITHIN SAID DISTRICT, ALL AS AUTHORIZED BY THE CONSTITUTION AND LAWS OF THE STATE OF TEXAS; SAID BONDS TO BE IN ADDITION TO THOSE BONDS AUTHORIZED AT SAID DISTRICT'S BOND ELECTIONS OF NOVEMBER 3, 1981 AND AUGUST 12, 1985?
